# Installation

## Hardware Installation

- 1. Connect a CAT5/6/6a Cable to the RJ45 Port on the Network Adapter and to a Network Device.
- 2. Connect the **USB-A Connector** on the **Network Adapter** to a USB-A port on the **Host Computer**.

## **Driver Installation**

- 1. If the **Drivers** do not automatically download when you connect the **Network Adapter** to the **Host Computer**, a message that a **Virtual CD** is loaded will appear.
- 2. Click on the message, the CD Drive screen will open.
