# Preparation

- 1. Ensure the surfaces to which the adhesive is to be applied, are clean and dry.
- 2. Always open and use adhesives over protected work surfaces.
- 3. Remove the cap and turn the tube base to slightly extend the glue stick.

# Application

- 1. Apply the glue with firm even strokes.
- 2. Wind glue stick back down into dispenser.
- 3. Remove any excess glue from body of stick with a clean tissue.
- 4. Replace the cap after use.

# Cleaning

- 1. Excess adhesive may be removed with a damp cloth.
- 2. Adhesive on clothing may be removed with water before the adhesive dries.
