If it is not possible to scrub the floor with water, cover the floor with suitable sheets of paper. These used sheets should be wrapped up in spills and transferred to a suitable container for disposal. Garments may be washed or dry cleaned, after removal of loose toner, always without the presence of heat to avoid permanent stains.

Chapter 7. HANDLING AND STORAGE

7.1 PRECAUTIONS FOR SAFE HANDLING

Keep out of reach of children.

Keep away from ignition sources. Avoid dust formation. Handle in adequately ventilated areas. Do not breathe dust. Do not get in eyes or on skin.
