#### Chapter 7. HANDLING AND STORAGE

##### 7.1 PRECAUTIONS FOR SAFE HANDLING

Keep out of reach of children.

Keep away from ignition sources. Avoid dust formation. Handle in adequately ventilated areas. Do not breathe dust. Do not get in eyes or on skin.
